Woodland Lifestyle Ltd and/or its appointed agent is hereby irrevocably granted permission from the purchaser(s), including the right to enter onto any premises owned or occupied by the purchaser, to retrieve product that has not been paid for in full by the agreed due date. The purchaser(s) will pay all costs and liabilities incurred by Woodland Lifestyle Ltd and/or its appointed agent in recovering any property. The purchaser(s) indemnify Woodland Lifestyle Ltd and/or its agents against all liability and actions arising from the recovery of overdue accounts, or the repossession of goods.
3. The purchaser will pay to Woodland Lifestyle Ltd all costs associated with the collection of overdue accounts including interest at 2.0% per calendar month of the overdue amounts.
