Description of Native Vinyl Plank Flooring

Native Vinyl Plank Flooring (Native) is a multi-layered resilient vinyl plank floor covering designed to be glued to the subfloor with a hard set adhesive. It is intended for use in heavy duty residential and commercial areas.

Native planks are 1524 mm in length, 5 mm thick and 228.6 mm wide. The surface wear layer is 0.7 mm thick.

Native is part of a system that includes Woodland or third party vinyl flooring adhesives, and may include combinations of third party moisture barriers, primers, and damp proof membranes.

Native has good slip resistance and is easily cleaned and impervious when installed in accordance with Woodland installation guidelines.
