Description of Building Product

Zenku Artec and Creation flooring

Zenku Artec and Creation flooring are high-quality Spanish manufactured laminate flooring planks. They are composed of an embossed pressed-bevel timber print on a water repellent HDF board.

It is intended for interior use including where exposed to water-splash (e.g. kitchens, bathrooms, laundries, toilets) but is not intended for use in areas of extreme humidity (e.g. saunas) or where tanking is required (e.g. shower enclosures or swimming pools). It is suitable for installation over underfloor pipe heating.

Boards are installed as a floating system.

Artec

The Artec range are pressed-bevel chevron pattern planks 319.6.1mm x 1330.3 mm (w x l) and are 8 mm thick. The planks include a press-bevel anchored click together system for simple installation. The surface of the anchoring system is impregnated with a paraffin to repel moisture.

Creation

The Creation range are pressed-bevel extra-wide planks 322.1 mm x 1334.3 mm (w x l) and are 8 mm thick. The planks include a press-bevel anchored click together system for simple installation. The surface of the anchoring system is impregnated with a paraffin to repel moisture.
